Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: red or yellow flakes.

Danger! Causes eye and skin burns. Causes digestive and respiratory tract burns. Harmful if swallowed. Decomposed even by weak acids, evolving hydrogen sulfide, H₂S, a flammable, poisonous gas with the odor of rotten eggs. Prolonged exposure may cause pulmonary edema. May cause cardiac disturbances. May cause central nervous system effects. Hygroscopic (absorbs moisture from the air). Very toxic to aquatic organisms.

Target Organs: Central nervous system, respiratory system, cardiovascular system, eyes, skin.

Potential Health Effects

Eye: Causes eye burns. May cause irreversible eye injury. May cause blindness. May cause chemical conjunctivitis and corneal damage.

Skin: Harmful if absorbed through the skin. Causes skin burns.

Ingestion: Harmful if swallowed. May cause severe and permanent damage to the digestive tract. Causes gastrointestinal tract burns. May cause dizziness, drowsiness, confusion, weakness, irregular breathing, and unconsciousness. Contact with stomach acids can liberate toxic hydrogen sulfide gas.

Inhalation: Causes chemical burns to the respiratory tract. Inhalation may be fatal as a result of spasm, inflammation, edema of the larynx and bronchi, chemical pneumonitis and pulmonary edema. May cause systemic effects.

Chronic: Effects may be delayed.

Section 4 - First Aid Measures

Eyes: Get medical aid immediately. Do NOT allow victim to rub eyes or keep eyes closed.

Extensive irrigation with water is required (at least 30 minutes).

Skin: Get medical aid immediately. Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

Ingestion: Do not induce vomiting. If victim is conscious and alert, give 2-4 cupfuls of milk or water. Get medical aid immediately.

Inhalation: Get medical aid immediately. Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Do NOT use mouth-to-mouth resuscitation. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask.

Notes to Physician: Treat symptomatically and supportively.
